Steve Layman, 915 Hawthorne Ln. - We have 55 acres of ground on Horns Hill Rd. that we would like to put a housing subdivision on. When we approached Council first time and Planning Commission, we asked for RM Zoning with a stipulation that it would be no more than 115 lots. We're not interested in a lot of density, this ground would support through zoning probably 150 lots, but we didn't want to do that. If you look at the drawing you'll see right in the middle there's about a 5 acre open space playground, ball field, we think it'll make a nice development. We asked for the RM zoning simply because we want to make the lots more clustered to build less road and preserve the open space. This doesn't really have anything to do with zoning, but at Planning Commission, the main opposition from the neighbors if I characterize it correctly was the connection between one of our streets and Meadowland Drive. We have in consultation with the engineers revised our initial drawing and that connection goes away and that is now planned, assuming the final plat is approved that way, a culdesac so there is no connection to the subdivision to the south. One other thing talked about at the Planning Commission, in lieu of building a turn lane, we are prepared to pay a \$1500.00 per lot impact fee to the city upon planning, the intention is that money would be used for improvements on Horns Hill Road where the City deems it most appropriate. It adds up to just under \$170,000. It's not an insignificant amount of money, it doesn't solve all problems, but it's certainly a start. With that said, we would like to develop a single family subdivision starting this summer, we believe the market is there. Originally the homes were going to be starting at \$280,000, I suspect now they will be more than that just because costs have gone up since we started this. We would like to have RM zoning.

Brian Wallwey, 1676 Abby Dr. – In the Meadowlands area where the connector road was going to go, I was here at the Planning Commission meeting when Mr. Layman presented his plans and I was one that expressed concern about the connector road and how it would generate additional noise in a neighborhood that generally is very quiet. I believe it's called Meadowlands for a reason, it's very calm, quiet and peaceful. I would like to take this opportunity to thank Mr. Layman for hearing our voices of concern and modifying the plans. I greatly appreciate that. One question is you mentioned that the plot where that connector road was planned to be would become a culdesac?

Mr. Layman – It will be a culdesac, so there will be no connection.

Mr. Wallwey – Do we know what will happen with that particular lot?

Mr. Layman – If I owned the lot after it was all done, I would ask to vacate it.

Not to be a stickler, but we are going to be voting on a rezoning and an annexation without the opportunity for citizen comment, I would like to suggest that we do citizens comments first, just in case someone might want the opportunity to comment on these particular issues.

President Ellington – Even though we just did a public hearing, I will go ahead and do that.

COMMENTS FROM CITIZENS

Rodney Coble, 308 Summer St. – I am here because of Coble Park. They feed the kids down there and the fence has been cut down there. I know the price of lumber is high right now, but they could take some old guardrail posts or something and drive them in the ground down there and put a cable or something to keep the vehicles from coming into the park or the children running out of the park. Also the picnic tables are so deteriorated that the boards are like U's. If they would just replace the ones that are bad, it would be a big help-. You have all the traffic coming down through there from Babe Ruth and you want the city to look nice. Plus, her sign is leaning at a 45 degree angle and at the top where it says City of Newark it's about rotted in half. I did speak with Mr. Rhodes and he got the graffiti off the sidewalk under the shelter, I deeply appreciate that because it was awful vulgar and the kids are there. Today, I was down there and picked up a brake caliper and a can of brake fluid up out of the parking lot, there's always people working on cars in the parking lot. I think maybe we need to put a light right there by the shelter house so it would be lit up more. Today I also picked up 2 phone things from the Salvation Army and put it in the trash basket. I just ask that maybe we can get some of these things addressed so the kids would have a decent place to eat their meals and make it safe, like I said there's a lot of traffic from Babe Ruth and if a car would go through the park, the trees aren't big enough to stop them and thy hang over the road and if a kid would run out, I mean what's few dollars compared to a kids life. All I'm asking for is someone to straighten the park up a little bit so it looks decent and make the city look presentable.

Mr. Lang – I wanted to congratulate the Newark Police Detectives for making an arrest for the unfortunate shooting that happened over the weekend. Swift action as always from the Newark Police and I just wanted to congratulate them on a job well done.

Mr. Marmie – I need to call a Finance Committee meeting for July 19th. I want to thank Property Maintenance they are doing a great job this year and anytime I have had to communicate with them on issues they've been very responsive, so I want to thank Joe Paul and also Director Hickman for the job that they do. I know it's a busy department and they can't get to everything right away, but they do end up getting to it. I also want to thank Director Rhodes for help with a couple of small issues in the past 15 days. He's been very responsive also in making sure I get

all of the information that I need. I think it was quite an exciting 4th of July in the City of Newark and for the City not having fireworks, wow, there was a lot of fireworks. direction. Mr. Coble, your concerns are heard. Mr. Rhodes will be all over that, he'll work with the Parks Department and he gets things done, so appreciate you coming in.

Mr. Harris – On Friday I had the privilege to go the the high school and speak to Linda Parks class, I think the Mayor went to a banquet or something back in May and it's the JOG Summer Work Program and she had asked me to speak on City Council and what they do and I got maps of the city with each ward and I passed the maps out. They were more interested in the ward that they lived in than most and they were really interested in what the President of Council does. I struggled to answer that question. I asked them to find what ward they lived in and everybody lived in a different ward which was nice, there were a couple people that lived in the same ward. They asked me which ward was the best and I said the 1st ward. They said why is that because it's the first? And I said no, it's because that's the ward I live in. While I was talking there was a young man right in the front row right beside me and he had his head down the whole time and I thought man I must be putting him to sleep and Mrs. Parks came over and tapped him and he said I'm not asleep, I'm listening. At the end we had questions and he asked the most questions and was the most interested of all the kids.
