COMMENTS FROM CITIZENS

Linda Mossholder, 224 Green Meadow Dr – I would like to inform the Council that the position that Councilman Blake had talked about the BHP Outreach coordinator has been filled and what I would like to offer Council is once this person is established in this job is that he would come and give a brief presentation on what this position would do. It will be a position that will work with people who are currently unsheltered, with landlords, with law and order, but maybe he can give you an overview of what the position will do. At the Homeless Outreach we meet from 12-2 every Saturday, we are seeing over 100 people every Saturday. Granted not all of those people are unsheltered, but having over 100 people come through in order to get food, clothing and socks, does indicate that we have some issues in the City and I am hoping we will be able to with the new Council members be able to address those.

Steven Smith, 237 Violet Ct – First I'd like to add my thanks to Dee and Jeremy and Sean for their service to the City, I appreciate their fine work. A number of times Council has tried to find solutions to problems and we've had a number of things brought up by Ms. Householder and Rochelle brought up some solutions with fentanyl strips. The example brought up was in Virginia where the strips were

decriminalized, which is unfortunate, but not the case in Ohio. I think this is a clear example of how the community should be contacting our representatives and asking them to forward this legislation to repeal the outlaw of fentanyl testing strips. This is something that saves lives and I just think it's the right thing to do.

Gary Babcock, 67 Philmont Ave – Dee, thank you very much, we had a lot of prayers going up for you during your illness, please leave your telephone line open. The younger people may need you. Jeremy, thank you for all that you've done for Council. Really in my heart I know you're going to continue your mission, the missions you've started and a lot you have completed and a lot aren't quite done yet, so please stay right in there and please run again. The rest of Council, thank you. You're probably more under paid and more over worked than anyone in the City of Newark. Sean, thank you. Bill Cost, stay active in the City Bill, appreciate what you have done.
