I believe we have to vote on the motion to reconsider first, and then we can vote on the amendment.

Motion made by Mr. Marmie to amend Resolution 20-18 to move the \$119,000 that was going towards police vehicles to Building Maintenance and Grounds. Second by Mr. Bubb Motion amend Resolution 20-18 passed by a vote of 10-0

**Mr. Marmie** – The police vehicles are not going to be dismissed, Mr. Rhodes will bring Legislation to the next Finance Committee Meeting to do a lease/purchase for the vehicles.

**Mr. Blake** – I just want to offer my words of support for this. Director Rhodes has been phenomenal helping us in the south end of Newark and the Little Texas area with the flooding there. Many of you may have read in the paper, but there was a lot of damage and clean up required. I appreciate everyone's support with all of that.

That was awesome. I want to welcome Janine to the city council. You did a great job tonight I want to give you kudos for that I know it's your first time tonight, not under normal circumstances but you don't know what normal is. I want to wish everyone well.

Mr. Barker – I would echo all of the thanks everyone has given tonight and add our grocery store workers, they are keeping our community fed and stocked. I know they're working around the clock for that. I'm thankful for everyone that we could make these virtual meetings work. Hoping we all get to see each other in a month, however it's looking like our next meetings may be this way as well.
