Mr. Fraizer- HHCA clean-up is April 21 and a transit meeting.

Mr. Lang- I would like to thank Chief Connell and Chief Connor as well as Deputy Chief McKee and Logan from NPD for meeting with me so I could hear what the safety forces have been up to and what the challenges are for their departments. We are really blessed with some great leadership, I learned a tremendous amount about the challenges they face by meeting with them. I had the pleasure of attending March for our Lives last Saturday on the square here in Newark. I went because I wanted to hear what the kids had to say and to show them that their elected officials are listening. We as public servants should recognize them when they stand up. Mr. Fennell I thought it was great with you introducing the girl from Licking Valley. I'm not sure that I agree with teaching our children that there shouldn't be any consequences for their actions. Civil disobedience has been and will continue to be an important part of free speech but the power of civil disobedience comes from the willingness to accept the consequences of those actions. The young people overall I think were really inspiring. I disagree with some of their solutions to the problem but I whole heartily agree that we have a serious problem with school safety in our community and we really need to be focused on that from all levels of government. I was encouraged by several of the young people who spoke with great depth and understanding about the complexity of the issue and that it is about more than just banning guns. Some of the kids were

divisive and partisan in their approach but honestly most of the kids were more practical and holistic in their approach than I know I would have been at their age. I want to commend them for the way that they spoke and the eloquence with which they spoke. After the young folks spoke the event turned and all of the adults running for office gave different versions of weren't those kids great. That means you should vote for me. The rally should have been more about the kids, a moment for them to speak and us to listen and we could have done that without making it about the adults who are running for office. I'm not saying that because I disagree with a different party candidate but neither party really has a monopoly on caring for the safety of our kids. I have kids and as a parent it really sickens me to think that my kids are going to be participating in active shooter drills. Regardless of party affiliation I think it has been my experience that parents, all parents care about the safety of their kids and we may disagree on how we achieve that goal. All and all I was really inspired by the courage of the kids and I am proud to live in a community where we teach our youth to be confident enough to stand up for themselves and we give them the opportunity to speak up.

Mr. Rath- I read an article in the Advocate about Newark City Schools and the things that they have done to address the safety issues. I want to commend Newark City Schools they have done an awful lot. They are leaders in some respects, followers in other respects but they have done an awful lot to address this issue. Called for a Service Committee meeting.

Mr. Blake- called a Finance Committee meeting. Our K-9 unit dogs are getting retired and there is a fundraiser for them at the Licking County Humane Society that will benefit the Newark Police K-9 unit on May 17th at 8:00 P.M. Tickets are \$20.00 apiece.

Mr. Bubb- our next meetings are on Monday April 16th. We will have Finance and Service Committees starting at 5:45 P.M. and then Council at 7:00 P.M.
