#### **COMMENTS FROM CITIZENS**

**Rachelle Bolen Smith, 237 Violet Ct-** asked Council to do a resolution of support condemning the Trump Administration Immigration Policy of Separating Children from their Families. She read a proposed resolution from Representative Dan Ramos.

**Daniel Crawford, 163 S 2**<sup>nd</sup> **Street**- he stated that he was in support of the resolution Mrs. Smith spoke of but suggested that it is more local and not reference the Democratic Party. He stated that he would be in favor as a taxpayer to pay for more patrolling where children/students are at whether they are private or public schools. He is in support of those who came to speak about keeping their students safe but he doesn't feel that closing the foot bridge is the right way to do that.

### **MISCELLANEOUS**

**Director Sassen-** I would like to clarify two issues Ms. Beam commented on, first of all my relationship with Ms. Beam dates back to 2010 not 2011. More importantly I don't want anyone up here to be of the understanding that the Newark Police Department doesn't have jurisdiction in the county building. Newark Police Department every building, every square inch of property within the political boundaries of the City of Newark and we have cooperation agreements with other departments so under certain circumstances they have jurisdiction beyond those political boundaries. So when she stated that the Newark Police Department doesn't have jurisdiction in the county building that is completely untrue. **Mr. Marmie**- called a Finance Committee Meeting.

**Mr. Rath**- Dave I just wanted to congratulate you on another successful great festival this year. Thank you also for the check, we appreciate that. I want to thank you and the Kiwanis for their generosity for working with me to get a group of kids that are special to me some tickets, they had a ball. He called for a Service Committee Meeting.

**Mr. Blake**- I want to wish everyone a happy Independence Day it is our country's 242 birthday. I hope people take time to reflect on our history but also celebrate where we are with our freedoms and things we are allowed that other citizens of the world aren't. Thank you Dave for the check to Wells Park. That park is in my Ward and I know that it is heavily used and the renovations that are being done are very much appreciated. I want to thank everybody who spoke here tonight either at committee or Council on various issues. One of the things that we celebrate this week with the Fourth of July is the courage to speak in our public venues before our public bodies.

**Mr. Cost-** I think that the discussion tonight was very good, there was a lot of good information. I would be in favor of looking at more enforcement in the areas that were discussed; I think that would be helpful, I know there are needs just like that all over the city. I think we could look at those areas and see what could be done. Also as a full disclosure a discussion about a sidewalk going south of the new bridge started the day that we cut the ribbon. When we walked off that bridge and across the walkway we found ourselves in a grassy knoll and that is being addressed and dealt with to see what we can do to make that happen. It is from the bridge down to Heartland bank on the west side going south. Mr. Fennell- I wanted to thank everyone who spoke tonight. The bridge in question is in the 7<sup>th</sup> Ward and it is clear that something needs to happen but there is trouble on both sides of that bridge. I don't believe right now that closing the bridge is the answer but I am more than happy to have a town hall to continue the discussion and continue to work with the parish. It is clear something needs to happen and I really want to be a part of that discussion so I think we need to continue to work together and continue that conversation.

Mr. Fraizer- I want to congratulate the administration on the progress they are making on Fory Park and Everett Park. They have been some substantial work done by the Licking County Foundation and other foundations and it really is a marked improvement for our community. It is something to be proud of. As far as the Pearl Street Bridge is concerned, I use the bridge when I bicycle down to the UDF with my wife, we live in that area and we use the bridge and we like to use it. With that being said having incidents where children are involved with weapons and drug activity and open air drug markets on a bridge should absolutely be addressed by this body and by this community and we absolutely have to do something about it; whether it is more discussion, more patrols, temporary closing something has to be done to break the trend that is going on there. I think that is absolutely a priority for our community as well as addressing the response of our safety forces to that area. When it comes to immigration I have a very unique perspective when it comes to immigration. I have a family member who has been working for I.C.E. for 35 years and I think genuinely the media misses the fact of the individuals who work for Immigration Custom Enforcement side of it that actually do care about the people that they are working with and they actually do try to do what is best for them. When it comes to the resolution we typically don't do non-binding resolutions because it is a little bit too political for us and it costs us money and we want to focus on what the work of the city is. Thank you for bringing that forward today but I wouldn't support a non-binding resolution especially one written by the Democratic Nation Committee.

Ms. Hall- I want to wish everyone a safe Fourth of July.
