Mr. Blake- thank Clifford and the two Mike's for coming to the meeting tonight and for reaching out to him about his concerns about the light at Isabelle Road and that he was right the Principal of Benjamin Franklin School also has concerns about the light at Isabelle being removed regarding safety for the school kids. He stated that they would set up a meeting with the Service Director to get everyone in the same room that has interest in the subject. He thanked Director Baum for having an impromptu meeting with one of his constituents prior to the Council meeting. He thanked Director Baum also for speaking at the Downtown Newark Association meeting regarding homelessness and several of the concerns businesses have regarding homelessness. I appreciate your comments this morning and I think that there are ways where Police can be useful in situations but I also think that there are some ways our social service agencies can step up and get directly involved rather than it just being a police action all the time. He thanked Mrs. Mossholder for coming in and speaking about the water fountains and the homelessness. Director Rhodes is working on that but we will follow up on that. He reminded everyone about the Kiwanis fish fry on Thursday evening for Camp O'Bannon.

Mr. Bubb- reminded everyone that this Saturday is Lite the Night Cruise In downtown Newark.

**Mr. Fraizer**- he thanked Clifford for coming in I liked all your comments. This administration has put a lot of time and effort into Cedar Hill Cemetery to make that what it deserves. I think that you are talking to the right people about your concerns regarding the light. He thanked Linda Mossholder for coming in and discussing the drinking fountain situation. I'm sure that it can be fixed and that it is absolutely necessary. He reminded everyone that River Round Up is Saturday. He thanked Downtown Cycles and Director Rhodes for letting him ramp at Flory Park. September 15<sup>th</sup> there is a transportation meeting. Everett Park and the Skate Park continue to make great progress. He thanked the administration and the Chief for coming forward with legislation for a new fire truck. It is absolutely something that we need and I am glad to see us continually make

investments in our community and infrastructure for the benefit of our community.

**Ms. Hall-** thanked Clifford for coming and talking about Isabelle. She also expressed her concerns about people running through the light there at Isabelle and National Dr.

Mr. Lang- thanked Mr. Simon for his comments. I mowed a cemetery when I was in high school and know that it is a challenging thing to do and hopefully we can continue to make that cemetery look nice. I absolutely agree with your concerns about the light at Isabelle Road and like Mr. Fraizer said I think that you are talking to the right folks. The Engineer's Department will take a good look at that and hopefully we can all get on the same page and do what is needed there. Thanked Mrs. Mossholder for everything that she does in our community to service the homeless and those that are down on their luck. I appreciate you bringing the water fountains to our attention. I'm glad to hear that Director Rhodes is on it. I will continue to extend my offer if there is an opportunity to donate water please continue that communication. He thanked Officer Beech for getting the speed trailer out on Londondale after we had a dog get hit there a few weeks ago.
