On Friday night Licking Memorial held their Lifetime Achievement reception and Chris Meyer was awarded that and I wanted to congratulate him. It was a nice turn out and well received. Yesterday was the Toy Run. It went from the Walmart in Heath down to our Salvation Army. They think that it might have been the largest ever, potentially 1000 motorcycles. Each motorcyclist had to submit one unwrapped toy, what a great way to start out the season.

**Mr. Blake**- I want to thank Tiffany Lawrence and her mother for coming in tonight. I think that they are out in the hallway trying to see Safety Director Baum so hopefully they will get an opportunity to speak to him about the issues on Manning St. I need to call on behalf of Councilman Marmie a Finance Committee meeting. **Mr. Fraizer**- I want to thank Scott Hayes and Vertical 196 for the work they are planning on doing and for the grand opening. Anything that we can do to ease the situation and find opportunities for people to get help should absolutely be embraced. I want to thank Director Mauter for coming and speaking to the committee today about the 2019 funding of the CDBG. The HHCA is going to have a meeting Thursday at 7:00 P.M. It is election Tuesday coming up tomorrow so good luck Jeremy on the election and encourage everyone to vote and be informed and make your voice heard at the polls.

**Ms. Hall**- I too would like to thank Scott Hayes for his efforts for the homeless and I think that might just be a beginning and thank you Mr. Mauter for your report.

**Mr. Labutis**- I want to thank Scott Hayes again for being here and for the great things he is doing for the city and it bridges a gap of something that wasn't there previously. I think that it is just the beginning and I am extremely proud of him and today he was able to change 38 lives. Make sure to vote tomorrow.

**Mr. Lang**- I would like to commend the citizens that are putting on the Citizens Police Academy. Mr. Rath and I had the pleasure of going out to the Newark firing range this past week and we had a very impressive demonstration from the Special Ops group. I won't steal Mr. Rath's thunder but Canine Unit did a very

interesting demonstration. They do some very challenging things and make it real easy. When that comes around again I advise anybody who has the opportunity to take that program to seize that opportunity. I would like to remind everybody to go vote tomorrow. There is one issue in particular I would urge everyone to vote no on Issue 1. While I do think that it does seem to address some very important issues in our community I don't think that it is the right way to go about it. I would like to point out that along with the Ohio State Bar Association and the Ohio Divisional Conference all 7 of our local elected judges have opposed that and most telling this past weekend the Ohio Society of Addiction medicine that is a group representing all the doctors that specialize in addiction medicine have out to oppose this. This is not about having or not having compassion for those that are addicted it is about whether or not we are addressing it and we are going to cause more good than harm. I think what is going to come out with the way Issue 1 is written is the opposite. We have some great judges here in Licking County and I am here for this particular issue because what it may do to our drug courts here locally, to what it may do to our municipal court budgets and I don't want to take discretion away from those judges. I would urge everyone to get out and vote and vote no on Issue 1. **Mr. Rath**- we have not had the opportunity to test the taser yet but I am looking forward to Mr. Lang stepping up and volunteering for that. It was interesting taking a bite from Bear one of our canine officers. It is incredibly intimidating and exhilarating; to put it simply it scared the crap out of me but when it was all said and done it was very fun. I appreciate Bear taking it easy on me and not missing the pad. I want to encourage everyone to get out there and do their civic duty tomorrow as I do every Monday before an election. I never endorse and individual candidate or an issue or encouraged anybody how to vote before in the nine years that I have been up here but I am going to implore you to vote no on Issue 1 it is that important that I will say it from right here. It will cost lives, it will take away valuable treatment programs, and it will be devastating to the State of Ohio. It will do nothing that it says it will do in the first four lines of the way that it was written. Not only that it is a constitutional amendment so it will take years and millions and millions of dollars to change it if everything I am saying is right or even if part of what I am saying is right. It is not a law it is a constitutional amendment so it will take forever and a lot of effort to fix it if it is wrong. As far as I know everybody that is an authority on the subject says that it is wrong, at least within the State of Ohio. All of the yes money and yes imploring and yes advertising is coming from outside the State of Ohio. Please, please vote no on Issue 1 I feel that strongly about it. I want to thank Scott Hayes for coming and doing the work that he is doing. I would like to call a Service Committee meeting.
