#### **COMMENTS FROM CITIZENS**

Kim Beem, P.O. Box 663 Johnstown- she discussed a personal incident where she claims to have been on the receiving end of telecommunication harassment but that there has been no chargers filed and no arrests made. She was asking for Council to do something about Judge Higgins and our Law Director not pursuing charges in addition to the probation department. She compared it to the incident in May where Mr. Hartless killed the 2 women and an officer before killing himself asking them to not allow these people to bully her into suicide because she had attempted that already in June. She stated that former Councilperson Rhonda Loomis was investigated for harassing her while she was at work and then subsequently terminated for that. She asked Council to hold the Law Director accountable for not pursuing the charges against Mrs. Loomis.

**Kris Tolliver, 381 Claredon St**- she asked for information about the house at 374 Claredon Street. She stated there weren't any utilities in the house, her and her husband have been mowing it and the owner stated to her that he is receiving bills from the city for property maintenance that he isn't paying along with taxes and a house payment. She wanted to know who was responsible for this property.

**Jim Foster, 903 Dietrach Ct-** he stated that he has been told for the last 8 years that the 21<sup>st</sup> Street railroad is going to get fixed. He also stated that the rail bed is below the road now on the 30<sup>th</sup> Street railroad. He wants River Road closed up because of speeders. He would like to have a Waffle House in Newark.

Greg Renda, 2239 Horns Hill Rd- he was there to voice concern about the city's special assessment procedure regarding the petition that was on the agenda tonight for residents of Fairway Estates. He was concerned about the petition being re-written. The first petitions there were 69 households and have been changed to 44 so essentially 25 households that will be affected by this project will not have the chance to determine if this project goes forward. Basically they will be able to get this project done without achieving the 51 property owner's agreement to this project. I'm concerned that we are re-writing the rules to make it so this petition works that is not taking in consideration the ORC

I would also like to thank the construction crews on the bridge for all of the progress they are making. I am excited for it to open.
