Mr. Bubb- he asked fellow Council members and people in the audience to support all of the businesses on North Park Place during the construction because it is a tough time for them because of traffic and we need to make sure they survive during this construction period. I encourage everyone to do their best to try to get down there once a week. **Mrs. Floyd**- the Final Friday for June is June 30th and it is a car show. It was on South 3rd Street like it was last year where the food truck festival was near where Lil Bear used to be. Canal Market will also be going on that day. On July 8th I think is the date there is a Carl Etherington Day that is sponsored by the jail. Carl Etherington is the young man that was hung in Newark. It is a day to highlight what happened there because he was taken from the jail down to the corner of the square.

Mr. Fraizer- thank you Chris for speaking and letting us know about Marcy's Law. I too would be interested in hearing more about it but if you have the Attorney General and the Licking County Prosecutor endorsing it that seems like a step in the right direction for protecting victim rights and encouraging appropriate judicial steps in order to protect victims and not make then revisit the crime that are out against them. I got two pieces of mail this week, one from the Licking County Humane Society of their annual report as well as the Licking County Foundation regarding their annual presentation of awards. I want to highlight the good work those two organizations are doing in our community and they continue to provide funds and means to protect and enable economic development and making the appropriate steps to keep moving us forward.

Mr. Johnson- I have submitted my letter of resignation to President Ellington that is effective June 30, 2017 but there is a Capital Improvement meeting next week. I want you to know that I have enjoyed my years on Council. I am very proud of our city and our Council especially our ability to develop a positive vision of the city. I think we stepped up to change Pit Bulls to vicious dogs and all dogs that attacks and should be labeled that way. We voted to eliminate discrimination at all levels, gender, race, age and disability. We haven't hidden from medical marijuana, it still needs positive work but our Federal Government needs to get their heads out of the smoke and deal with the positives of medical marijuana. We have selected two fine leaders as Chief of Police and Fire Chief; we tried to educate the public about the additional taxes and the need without success but we still need money. We can't depend on our state or national funds to come our way. I want to thank the voters that gave me the opportunity to serve. Voters remember what the President does, what the Governor does and the state and national representatives have little effect on your lives but what these City Councilmembers do has great effect on your life. I thank my wife, son and family for putting up with my political aspirations. I want to thank members of Council and the administration for support. Keep up the good work. **President Ellington**- Curtis you have done a great job since you have been here and I know speaking for all of us up here we will all miss you and thank you for your service.
