Mrs. Floyd- called for a Street Committee Meeting

Mr. Fraizer- I'm really excited about what we had on the agenda tonight, we has a special improvement tax district and a lot of bond reorganizations to manage our long term debt and we continue to see progress in our community. Throughout this year we have seen the debate back and forth on the medical marijuana issue. The State Government has released their final laws regarding dispensaries, I reviewed it and am working on legislation to give to the Law Director to compile to form and hopefully will be brought to committee in three weeks. Highlights as far as what the rules state, Rule 3796 according to the State of Ohio is 500 feet from a school, church, library, public playground and public park as well as 500 feet from an addictive services. They have also categorized the state into multiple districts of which we reside in district 4 consisting of Licking, Knox, Morrow and Delaware County of which three dispensaries are allowed. The legislation that I want to present is to provide adequate zoning and sufficient oversight for the City of Newark in order to make sure we are aware of what dispensaries are provided provisional licenses, what dispensaries have permanent licenses and set a framework in place to make sure they maintain a communication channel to keep us up to date and their compliance with the State. I wanted to make that announcement to keep everybody on the same page to work through this issue as diligently and effectively as possible.
