COMMENTS FROM CITIZENS

William Butcher, 263 Union St- thanked the city for getting the pot holes in the alley where he lives fixed and provided a weather forecast.

Michael Blain, 124 S Cedar St- he advised Council of the problem that residents of Candlewick are having with teenagers loitering outside in front of McDonalds on the sidewalk to the point that they don't feel safe walking down that side of the sidewalk. He stated that a teenage boy was beat up and sent to University hospital due to the injuries he suffered from three of the people standing out on the sidewalk. He also stated that the residents of Candlewick are afraid to step outside of their apartment because of the congregation of kids outside of McDonalds.

Mike Frasier, 20 W North St- my residence borders the North St Park and as a part of community improvement I have proposed to the Historical Hudson Community Association that we do some landscaping in the park in order to improve the look and the feel of the park. That is going to be paid for out of my own pocket and we would like a resolution from City Council supporting this as a bipartisan move. What we are looking to do is a retaining wall on the west portion and use it as a

stepping stone to bring about an all over improvement to the park. The Hudson Historical identified this as a major initiative that they wanted to embark on and they have been doing fundraisers to try to achieve this goal. I wanted to take part and put forth my own effort. I am looking for volunteers, I have paid for the materials and we are going to perform the work as soon as possible, a day we are looking at is this weekend. I feel like this is a step in the right direction for improving our city's parks and improving our community.

Ms. Mary Borgia's 5th Grade Class from McGuffey Elementary- gave short presentation informing City Council the reasons they should support Resolution 15-40.

Melissa Lanter, Manager of Washington Square Plaza representing Beacon 360 Management- she manages 340 Eastern Ave, Washington Square Plaza. She provided an update on the renovations of the buildings and grounds they manage that she spoke of at last month's City Council Meeting. She stated that they also manage Candlewick Commons and confirmed the concerns and complaints from the residents that Mr. Blain spoke of. She stated that there are at times up to 20-25 teens blocking the door. Ground breaking for the new playground at the townhomes at 425 Washington has started. The ribbon ceremony will be June 4th at noon. She invited City Council members to come. She stated that the concerns of Beacon 360 Management are the vacant dilapidated houses in their area. She stated that there is a lot of drug activity and crime going on at the boarded up buildings. She is asking for the city's help with improving or removing those structures in an effort to help improve and give the east side of town a new imagine. On Saturday June 13th Washington Square Plaza is having a block party for the neighborhood and invited Council to that as well.

Mr. Rath- on the third page towards the bottom there is a property on the list 61 Bowers Ave owned by Judith Green with a proposed lien of \$1442.00. I reviewed my notes this morning and I returned the proprietor's call and we weren't able to speak but the law doesn't allow exclusion just because they didn't get notified. This is a property that we had dealt with for over a year and it was mitigated recently. I am unaware that the law gives me some sort of discretion that since it is fixed the fines be taken away.

Mr. Rath- I am shocked, nonetheless I will be voting no on the amendment because this is information that I was not made aware of. I was under the impression that the administration was with this so I will be voting no on my own amendment. **Motion to amend Ordinance 15-13 failed by a 10-0 vote.**

COMMENTS FROM CITIZENS

William Butcher, 263 Union St- he thinks his street should be paved first. Another weather update given. Devin McDonald, 77 Bowers Ave- he would like to see the opening of South Second St and that it gets paved. Paul Moran, 63 N 4th – he suggested two locations of where Farmer's Market could go downtown versus Madison Township. He mentioned the fact that both Fitness Centers downtown are gone, Body Core and Newark Cross Fit and Daugherty TV Service due to illness of the owner. He feels as though this information should be in the paper but since it isn't he is making us aware.

Dave McElfrsh, 153 N 39th St- I am here speaking tonight as President of Newark Firefighters Local 109. The current proposal could impact public safety. I stand here today looking to work with the administration to address the issue that could result in delays of service and impact the safety of citizens. This new proposal further cuts our staffing, taking necessary Fire and EMS vehicles out of service through brown outs and cross staffing and potentially closing station 4. We have discussed with some of you recently as we continue to question some of the numbers and budget info from the city management. I would ask that we slow down on these cuts until we have an accurate budget number to work with. After several meetings with the Mayor, Safety Director and the Auditor's office we are still looking at a moving target but

we are making cuts now. On the job injuries are already taking a toll on our staffing. The recent proposal would further reduce the ability of our firefighters to protect our citizens. The city already has 20% fewer firefighters. While we understand budget limitations, we are already doing more with less. It can't continue if we want to call ourselves a safe city. We are already staffed well below industry standards. We have worked diligently with Chief Connor to address the budget issues. I want to make it clear that the issues mentioned above are above the Fire Chief he can only work with what the administration has given him. The issue is not one of available budget space we believe that the money is there. It is a question of priorities. Is the city ready to roll the dice? Is the priorities public safety or is it creating a rainy day fund with threats of impending financial ruin. Newark firefighters hold public safety in high regard is the reason that we come to work every day. We serve the citizens as does this City Council and they deserve a safe city.

Daniel Crawford, 163 S 2nd St- Our city recently celebrated the destruction of a handful of blighted houses. I, too, am grateful that we are using our resources to deal with these troublesome properties. However, I have to ask: does demolition have to be the only answer? With what - if anything - are we planning to replace the obliterated heaps of wood, glass, and metal? Previously, I've addressed the humanitarian crisis of homelessness. I believe that we can partially deal with that problem while also handling our condemned properties. Instead of spending taxpayer dollars to lay waste to these buildings, why not use those funds to fix same said structures or replace them with new ones for the purpose of providing an affordable home? After all, the primary root cause of homelessness is the lack of availability in housing within the victim's price range. I don't know about you, but I would rather our community be part of the solution, not the problem. If it is too expensive for the city to take on this task alone, then we should offer incentives to prospective property owners to buy the building in question and transform it into a safe, cheap home for someone in need. Perhaps even working with organizations like the Habitat for Humanity could be an option. Or, we can seriously consider using the empty space for the construction of a village of small single-bedroom homes for the homeless; as has been done in states like Wisconsin, Oregon, and California. Honestly, the symbolism of optimism offered by erecting a new home out of another's ashes beats the pessimism I see of leaving the space empty once the rubble is cleared away. Rethinking our use of the wrecking ball is far from the only option before us. Beyond the condemned houses, it would be beneficial to the community as a whole if affordable housing wasn't limited to the typically poor parts of town. Though it might make some uncomfortable, a community is best served when its inhabitants rich, poor, and everything in between live amongst each other as opposed to being separated from those unlike them. Moreover, allowing the poorest citizens to join their affluent compatriots enhances the likelihood that they will receive a quality education, thereby increasing their chances of climbing out of poverty. So, in essence, affordable housing is an issue of homelessness today as well as preventing such in the future. However, continuing the trend of leading our impoverished brothers and sisters down the path of perpetual misery is not an option. If breaking the cycle and fighting poverty is desired, then it is incumbent upon us to recognize the public threat of homelessness as well as embrace the solutions thereof. We can't just simply ignore this vital issue if we truly care about what is in the best interest of our community. With spring having arrived and with it the spirit of hope and new beginnings, I ask you to ponder what I have said. No single policy or government action is going to solve homelessness, but that doesn't render action useless. At the very least, we can make it easier to avoid living on the streets by doing something to ensure that an affordable place to call home is within reach and is located in an area that will help lift, not trap, the individual and their children. A place of promise, that's the Newark I like to think of, and I'm sure that each of you feels the same way. Let's make that vision a reality by touching the lives of our forgotten.

Devin McDonald- advised City Council that the playground behind Mound City Ball Park is unsafe and needs to be refurbished or replaced.

MISCELLANEOUS

Mayor Hall- I want to thank the McGuffey students for coming out. I spent about 6 years at McGuffey and I am very proud of that school. Thursday we launched our Ticket or Click It Campaign. That is he Newark Fire Department, Newark Police Department in cooperation with the Licking County Sherriff's Department and the Granville Post of the State

Highway Patrol. It is through the end of the month which includes this upcoming Memorial Day weekend. I suggest everyone click it or you will ticket. We had 19 traffic related deaths in Licking County last year and 63% of them were not wearing safety belts. Obviously it is proven that you have a far better chance at surviving a crash with a belt on. **Mr. Johnson**- I want to congratulate the student from McGuffey school because that was a good presentation. I also want to thank the administration because I keep getting good things from people in my ward about the paving of Sharon Valley and Londondale.

Mr. Marmie- I want to thank the students of McGuffey also for coming out and actually exercising a great opportunity for them as far as a learning process. It's not like reading it out of a book; I appreciate you actually executing a plan. It is fantastic what you have done and I hope that you have enjoyed it. I am sure that it is something that you will remember for quite a long time. Hopefully it will be in the newspaper tomorrow and you will be able to cut it out and keep it in a scrapbook. Thanks to Ms. Borgia also. It was nice to be able to finally vote on a capital improvement piece since it deals with paving. I too like Mr. McElfresh believe in priorities. I believe in our safety forces and I believe in our infrastructure. The funds going into our infrastructure are very low and I know that it is something important to this community, not only the citizens, safety and economic development for different areas. I want to wish all of the local sports teams' good fortune.

Mr. Rath-I want to thank the McGuffey students and Ms. Borgia for coming out and thank you in particular for educating me, I know I learned a lot from you. I want to promote that next Friday the 29th is the Final Friday Food Truck Festival. I want to wish everyone a Happy Memorial Day and I would challenge you to think about why we have a three say weekend and it's not just to have a BBQ.

Mr. Rolletta- I too want to thank the students from McGuffey and Ms. Borgia and Dr. Shields and Dr. Leper and their good work advocating for our Historic Earthworks.

Mr. Blake- I have already thanked the student and Ms. Borgia so I will say keep up the good work and if there is anything that I can do or anybody else who is willing to participate will help out where we can. Another group of students that we have been working with this year has concluded their first year of service. I want to thank the Mayor for working with me on the project and that is the Newark Youth Council. 14 students sat up here amongst these chairs where they had different discussions and had presentations from different city administrators. I want to thank members of Council who came to some meetings also. Today I want to specifically recognize the teachers that helped us organize this. The 14 students who sat in our seat were selected from their respective teachers. Daniel stood up here and mentioned poverty and I want to sort of echo his comments. According to the census a third of our population exists in poverty. When we are dealing with that situation it can be such a broad issue. We could be dealing with transportation, housing, education, substance abuse, mental health issues or even just employment. When we focus on employment a sub-section of people in poverty are people that have served their time within the our criminal justice system and they have come out and participated in one of our programs like the Spencer House, The Courage House or Mental Health America or other good non-profit organizations that exist within our city and they are trying to become productive citizens within our society after they have made their mistakes and lived up to that. One of the barriers that these individuals come across is a term that some of you may have read in The Dispatch or The Newark Advocate is called "Ban the Box". Recently there was an article in the Advocate talking about how the State of Ohio has removed that conviction box from job applications. The State has voluntarily done that if you are applying for a State agency. I have been working with Director Sassen and Director Buskirk on this issue for a local ordinance. I like Director Sassen's term, not necessarily "Ban the Box" but "Delaying the Box". What we are trying to do is to get people to fill out the application but still be able to get to the interview. We don't want to get rid of background checks, we want complete transparency; we are just trying to get people in the door so that they can get an interview so I like that term "Delay the Box" and I am glad that Doug put that in my mind. Licking Memorial Hospital is going to be hosting a meeting with different Human Resource Directors on Friday June 5th at 2:00. It is going to be a discussion about fair hiring policies with several different major employers within our community and hopefully the City of Newark will join that. Licking Memorial Hospital and Denison University are on board with this and our own State Representative Scott Ryan has come out publicly supporting this as well.

He also called for a Finance Committee meeting for Tuesday May 26th.

Mr. Bubb- I want to also congratulate the students from McGuffey for a successful project. I too went to McGuffey kindergarten through 5th grade. I am very proud of you guys.

Mr. Cost- Ms. Borgia you should be really proud of your kids and with you being a fine Newark product yourself that has to be a good feeling. Dr. Leper, Dr. Shields it has to be nice realizing that your message is moving on to another generation. That has got to feel really good. Mr. Frazier, thank you for your project we appreciate it very much. Mrs. Floyd- as a retired Newark City History, Government, Civics teacher I am very proud of you guys you did a wonderful job. Thank you Ms. Borgia you did a great job too. I think this is important in your educational experience as well as important for the City of Newark. Jeff mentioned the Final Fridays Event and I just wanted to mention a couple of other things. The Final Fridays was designed by the Downtown Newark Association as a way to get people to come downtown and see what is downtown and you go to the various stores and see what restaurants and different shops there are. May 29th is the food truck, June 26th is a chocolate experience, July 31st and August 1st there is a combination art show, history tour and guilt show at the First Presbyterian Church. At most of these Final Fridays we can all purchase a "We Dig Newark" t-shirt for the bid dig that will be going on for a while now. The First Presbyterian Church is also having their Community Round Table meetings the first Wednesday of the months of June, July and August. There is a lunch provided. In June the Mayor will be there to speak, July is Cheri Hottinger from the Chamber of Commerce and in August is the Director of Community Development Mark Mauter. For those of you who mentioned the problems downtown on the west side of the square with teenagers, I had a couple of people comment to me about that and I talked to Bill Spurgeon. Bill, the Mayor, Fred from the CIC and the Interim Police Chief were at the meeting where they said that if there is a problem or people feel unsafe you should call the non-emergency police line at 670-7201. Then the police will come down and check it out.

Mr. Guthrie- along that same point that Mrs. Floyd just made, I think we all appreciate Mr. Blain's comments and I think that everybody here cares about safety not only on the square but in the entire city especially now when we have a shortage of Police Officers. Some of the businesses downtown can be helpful by trying to discourage this kind of loitering in front of their businesses. I think that it points to a serious problem that we all need to take serious and do everything that we can to make sure that we work with the administration to see that we have adequate patrols so that our citizens feel safe downtown and elsewhere in our city. A couple of other things that I want to mention talking about law enforcement, I know a number of us attended the Newark Police Awards Ceremony and I just want to say for myself that listening to the presentations of the awards at the Mid Land last week reinforced for me the importance of the safety piece and the human piece of coordination and collaboration between our Police Dispatchers and our Police Officers. Just to hear how they work together in some very tedious situations again reinforced for me why I am so skeptical of the idea of moving that service to the County. Along the points that Mr. McElfresh made, something as a Council that I think we need to is keep a close eye on is the budgeting. The administration presents a budget to us for X number of personnel not only in Police and Fire but in other departments and it seems like we don't fill all of the vacancies that we fund, I know that is an administrative decision but then we end up using the money for other purposes that Council really didn't intend to use it for. So I think that we need to engage in that whole discussion. I thought maybe the Safety Director could check on this and let me now or let us know and that is, I know we are doing a lot of mutual aid with EMS now and it would just be interesting to know if possible what impact this is having on our EMS billing because obviously if Heath, Newark Township or Granville does in EMS run in the City of Newark I don't think that we are able to bill for it and I think that it would be nice to know the impact that those mutual aid runs are having on the EMS billing.

Our family has established a non-profit with the American Childhood Cancer Organization to raise money for families that are on a similar journey with childhood cancer. The first big event that we are having here in the City of Newark is going to be on the 13th of June at the GMP Hall on Hudson Ave. It is going to be pretty much an all-day rummage sale. All the work by this non-profit id volunteer and all of the funds are going to be used to support Central Ohio families that have children with pediatric cancer. There is going to be a 5K in August and hopefully a chili cook off in October. **Ms. Hall**- I would like to thank Ms. Borgia and your class. You guys did a great job and did a lot of work. Hang in there and keep going. There might be bumps but you can get over those.
