ADMINISTRATION

Director Spurgeon- I would like to thank the committee for your support of 14-02. In short term you will have enhanced the safety up there and in the long term you will have expanded the tax base. I really appreciate it. I just want to give you a quick update on Property Maintenance. It has been a good year in 2013 the numbers are in and we conducted a review. A couple of highlights, it was a robust administrative review. We have had some revisions which allowed us to expedite complaints or reduce costs and our inspections were 33%, in 2012 we did 1,429 and in 2013 2,126. We did that with Director Mauter's and Director Buskirk's help. We found some efficiencies in DOD and was able to use one of the workers over there. So the

question becomes what we are going to do this year to keep the ball rolling. The take away is that we have some efficiencies with the computer hardware and software that this committee allowed us to spend some money on. I believe that we can have George doing some non-technical inspections about 8 hours a week and we also have Nate Strauss in Brian's department do some inspections, about 12 hours a week. So the take away, Mondays & Fridays we are going to have about 4 hours a day each for George, Tuesday, Wednesday and Thursday 4 hours each for Nate. There will a likely hood of 2 inspectors on duty at all times. Our work has just begun; we will continue to find efficiencies and continue to do a good job. The Mayor thinks that this is important and so do I. Thank you for your support we appreciate it.

Bill was there within minutes and the squad was there very shortly after the call and the police were there. Bill asked me to convey to Council and the administration that the way the Fire and Police Department handled the family was just amazing and the professionalism was second to none. Mr. Marmie- Unfortunately the Newark High girls were not successful in their tournament run but I understand that they had a very good year and that they were very pleased with their results and how far they did get. There are still 3 teams in the race this week. The Newark High boys basketball team plays this week and they are bid for a District title, the Newark Catholic boys are trying to get their district title they will be playing this week, possibly a couple of games and the Newark Catholic girls will be playing this week in the regional bid because they already won the district. We wish them all good fortune. I want to verbally thank all Council for the flowers, the cards, the thoughts and the prayers for the passing of my mother. I also want to publicly thank the IAFF, they sent a beautiful large bouquet of flowers that were just very touching and I really appreciate it. What Mr. Guthrie said I can say that I experienced. It was phenomenal what the fire fighters did. They were the first to arrive on the scene when my brother and I found my mother. The way that the treated us the way they handled things, the explanations was fantastic. Then the Police Department came right after that to more or less relieve the fire department. They guided us in the appropriate steps that needed to be taken. I already conveyed all this to Director Spurgeon. Our safety forces in those little times of need, it wasn't an emergency but it was definitely in my opinion critical, they did an outstanding job and I am very proud of them.

Every year we get to enjoy the beautiful courthouse lit up and Jay was absolutely the driving force behind that every year. He also made many contributions to the Heisey Museum. It is a very sad story; he was just diagnosed in December with stage 4 so his passing sadly came very fast. So I would ask everyone to keep the Barker family in their thoughts and prayers. In his memory they are going to install a sound system above the courthouse by the clock that is going to play during the Christmas season. It will be kind of an update to our square music. The music can be changed for the different events around the square.
