Mr. Marmie - if we are going to pass this and open the pool we need to get started on renovations immediately and make sure the YMCA can order everything it needs.

I am going to support this because I want the pool to open and hope we can work out all the difficulties that have happened in the past and make sure it's going to be something feasible for the city to do for the future. I would like for the city to look at this at the end of the year to decide if it's worth taxpayer dollars as far as what's being spent out and what we anticipate being spent in the future. I will support this at this time.

Mr. Rath - commended Mr. Rhodes and the city employees who are going to do the labor on this at significant cost savings to the city, which is the main reason we are able to open this. I look forward to such a facility being utilized and improved significantly over what we could afford. Kudos to those city employees.

Mr. Guthrie - expressed his appreciation to the administration, mayor, David Rhodes, and Mr. Mauter for moving forward on this important issue to our community. We're doing a good thing here.

Motion by Mr. Marmie, second by Mr. Cost to adopt Resolution No. 12-15. The motion carried by a vote of 9 yeas, 1 nay (Frost)

COMMENTS FROM CITIZENS

William Butcher - 129 West Main Street, voiced concerns about the vacant building behind his apartment building; it's not safe and something needs to be done with it. There are semis parked on the empty lot, too.

Daniel Coffman - 920 West Main Street, just a correction for the record, I did not purchase the Hudson Avenue home; I was a part-time employee for the City of Newark working the NSP Grant when that home was purchased. Judith Carr was the director of the department who had a plan specifically set up to purchase that home with HODAG dollars and there was a plan for utilization of HODAG dollars over the course of several years. I would like the record corrected that I ran the paperwork for her because I was an experienced real estate professional and I negotiated the deal for her but it is important that we stop saying that I purchased that home and the associated perceived difficulties with repairing that home. If anyone would like to understand the plan that Judith Carr had articulated to me I'll be happy to discuss that with anyone and provide them with those details; I have all of the records and all of the conversation notes.

MISCELLANEOUS

David Rhodes - Service Director, thank you for support on the Hollander Pool and I'll keep you updated.

William Spurgeon - Safety Director, as of 3:30 today the owner of the house at the rear of 127 West Main Street has taken responsibility. One van has been removed; there is a dump truck with a trailer full of refuse. There is work to remain but at this time they are being responsive to us.

Mr. Bubb - are political signs that are on the right of ways all over town being addressed?

Mr. Rhodes - last Friday I contacted the county commissioner candidates whose signs have been put out and advised them this coming week we will be removing some of those signs that are in the right of ways. There are two issues on the ballot and I haven't been able to reach those people.

For the November election I'm sending all the candidates and groups putting forth a complaint a copy of the city's sign ordinance. That should help to alleviate any confusion.

Mr. Bubb - called a personnel committee meeting for next Monday, Judge Michael Higgins has requested time to speak

Mr. Cost - feels really good about what we're doing with Hollander pool. It's a good decision, good for the community and I'm glad to see that moving on

Mrs. Floyd - the property William keeps talking about between the library and Licking County Players is an eyesore when you drive by on West Main Street.

Complimented all the city employees, we have a lot of people who work awfully hard. Thank you for all that you do.

The Midland is such a gem in downtown Newark with so many wonderful shows there. They are also doing a lot with their STEM Program, which deals with technology and education.

It's basketball tournament time. Jim Tressel was a shooter at Newark High School Friday night and was very gracious to everyone.

Mr. Guthrie - Darrin Logan's son is doing a great job along with the rest of the team.

Mrs. Loomis - encouraged Mayor Hall, Mr. Mauter, and the administration to begin looking at the city CIC, focus mostly on transit and lead at this time. That's the reason for my no vote on Ordinance 12-4.

Mr. Marmie - announced finance committee will meet Monday in council chambers at 5:30 p.m.

We need to look at where there are duplication of services within our community being the county and the city. The governor has definitely made it clear in order to save taxpayers' dollars if you can consolidate and do a better job, and provide more dollars to go to the actual services versus administration then it is better served. I hope we look at all those things.

I've looked at HODAG and whether or not that could be used for the house on Hudson Avenue. Mr. Mauter has made it clear he will look into that and make sure it meets those qualifications; we need to have verification before spending more dollars on that.
