Adult Probation came today along with Municipal Court and the Law Director concerning some arraignments that occurred over the weekend, IT along with AlpaLink installed fans to keep the servers cool and prevent them from crashing, Carl and Fred have assisted as needed as well. Transit was shut down on Saturday due to fuel issues, however residents can utilize the services of 211, Hollander pool is ready to go with the exception of AEP has issues to address with the pole, issues at Horns Hill tower have been resolved.
