1. **Resolution No. 18-01** a resolution authorizing and directing the Mayor of the City of Newark to prepare and submit applications to the Department of Homeland Security, for fiscal year 2017 Fire Act Grant Programs, in support of training programs, equipment purchases, funding for personnel, fire prevention, and fire safety programs throughout the city was considered.
