- 1. **Resolution No. 18-54** appropriating monies for the current expenses of the municipal corporation was considered. Expedite
- Section 1. There is hereby an appropriation of the unappropriated balance of the 153 Compensated Absences Fund, in the amount of \$15,442.00 (Payout A. Morris)

Director Baum- this is for Hepatitis B vaccinations for the Police Department they are not offered to them the way they are to the Firefighters during their certification process. The Police Department comes into contact with communicable and blood born pathogens during their careers. We are going to include Property Maintenance in this as well. It is a series of 3-4 shots there is also a test that you have to take to see whether or not the test stuck or not. We have shopped around and tried to find the cheapest price and that can be up to \$30,000.00. If someone's test doesn't take the whole series we are asking that you appropriate the \$30,000.00 just to make sure to cover the costs this is worst case scenario but could be less.

Mr. **Fraizer**- does some of them have the Hepatitis B vaccination already? **Director Baum**- some might have it from when the Health Department was still under the city, I have it from then but it wouldn't be likely since I would be at the top of the seniority list.

Mr. Cost- is this one time?

Director Baum- it is a series of 3-4 but then you take the test to make sure they all stuck.

Mr. Marmie- it will become a regular line item in the budget but it will only be for new hires in the future.

Director Baum- we figured it to be 2,000.00-3,000.00

Mr. Blake- does our County Health Department provide this? Director Baum- they do but they were not below this price. Motion passed by a vote of 5-0.
