2. **Resolution No. 15-28** authorizing the Mayor of the City of Newark to enter into a Community Development Block Grant funded subrecipient agreement with the

hereinafter named organizations to carry out activities included within Newark's FY 2015 Community Development Block Grant one year action plan was considered.

Barbara Gilkes- our 2015 plan for the use of funds has been submitted to HUD so I want to get the legislation ready so that when everything is clear with HUD we can begin our program year. The various sub recipients are listed under section one. All of the organizations a-d will receive \$4,000.00 to implement their programs. E, the CIC will receive \$60,000.00, F- Denison University Garden of Hope \$1,000.00, G- Licking County Coalition of Housing, homeless prevention program \$4,000.00, H- South Newark Civic Association \$1,500.00 for clean-up and safety programing, I- The Works has asked for funding to make ADA improvements for their main entrance to the museum J- The Woodlands, we are going to provide a match for one of their State Grants through the Department of Safety. All together our sub recipients amount to \$87,500.00. **Mr. Blake**- I will be abstaining from this vote because I sit on the Board of Directors for the Behavioral Health Partners and I also sit on the Board for the South Newark Civic Association.

Motion by Mrs. Floyd to send to full Council, second Mr. Cost Motion passed by a vote of 4-0, 1 abstention.

3. **Resolution No. 15-29** authorizing and directing the Mayor of the City of Newark to prepare and submit applications to the Ohio Governor's Office of Criminal Justice Services for fiscal year 2015 Edward Byrne Justice Assistance Grant funding was considered.

Barbara Gilkes- this will be an application for calendar year 2016. The application will be submitted in May. Bob Carson and I will be getting together to discuss the technology needs for the Division of Police.

Motion by Mr. Bubb to send to full Council, second by Mrs. Floyd Motion passed by a vote of 5-0.

4. **Resolution No. 15-30** authorizing and directing the Mayor of the City of Newark to submit an application to the Ohio Department of Public Safety Office for federal fiscal year 2016 Ohio Traffic Safety Grants Programs: Selective Traffic Enforcement Program (step) and the Impaired Driving Enforcement program (idep) was considered.

Barbara Gilkes- Newark is eligible this year. We just found out that unfortunately due to our traffic fatalities we are eligible for another year. It is good on one hand that we will be able to pay for overtime in areas we have significant issues with such as St Rt 79, St Rt 16, St Rt 13 and the 21st St area. The data indicated that we have a lot of wreck less driving in those areas. We have prom going on right now with our current Traffic Enforcement Grant so you will see overtime We are also gearing up for the Click It or Ticket Campaign which is worldwide

Mr. Blake- so basically this grant is paying for the extra services our police officers are doing.

Barbara Gilkes- right they are targeting those areas. The police officers using that grant have to have certain certifications to even work the grant.

5. Resolution No. 15-37 appropriating monies for the municipal corporation was considered.

Roger Loomis- this is appropriating money from a 2012 bond issue for water, wastewater and stormwater line improvements though out the city. Money was appropriating in various placed and this was the last project that has collected money left over from other projects. This is collecting those funds and putting them in the proper funds so we can do the Willrich-Yorkshire project this year which is part of our master plan in the Morgan Manor area to replace a lot of the water lines up there. As you may or may not know those lines were put in in the late 60's and early 70's and have caused us many problems. We have had many leaks in that area. This also goes in conjunction with the paving project that we are going to be doing this fall.
