We wish to report:

1. Resolution No. 13-37 authorizing and directing the Mayor of the City of Newark to apply for funding from the United States Department of Justice, Bureau of Justice Assistance under the Bulletproof Vest Partnership Grant Program was considered.

Barbara Gilkes- explained this is for their annual application, which paid for 71 bullet proof vests over the last year so the majority of police officers have new vests, but we are going to apply again because this is a multi-year grant. There are new officers coming in and the vests are tailored to each officer.
