We wish to report:

- 1. **Resolution No. 13-65** appropriating monies for the current expenses of the municipal corporation was discussed.
 - a) A request for an appropriation of the unappropriated balance of the100, General Fund, in the amount of \$1,000.00 (Check received from donor for renovation of Courthouse Square fountain)

Director Rhodes- stated this is an appropriation of the unappropriated balance for \$5,134.93 it is received for fuel costs for the Parks staff part time from the Job and Family Services Program Ms. Gilkes brought forth. **Motion by Mrs. Floyd to send to full Council, second by Mr. Frost Motion passed by a 5-0 vote.** c) an appropriation of the unappropriated balance of the 100, General Fund, in the amount of \$2,050.00 (check received to repair the damage to cemetery roof at 275 N Cedar St)

Director Rhodes- explained that this request was for additional damage to the cemetery roof that they have heard him speak about, this is the same roof. They discovered that some of the roof trusses were rotted once they opened it up. They got the contractor out there to look at it and an insurance adjuster. This is additional money received from the insurance company to get it fixed properly.
