We wish to report:

 Resolution No. 16-101 a Final Resolution cooperating with ODOT in carrying out the LIC-CR125-02.10 project which is a resurfacing project on North 21st Street from Granville Road to State Route 13 (Mt. Vernon Road) was considered.

Brian Morehead- this is our final legislation with our share of the funding included to be paid towards the resurfacing of North 21st Street from Granville Road up to State Route 13 which is planned for next summer. Our share of the funds is \$254,410.00. There is almost 2 million dollars of Federal funding in the project. This is standard final legislation that comes from ODOT that you have seen on other projects and I believe that it has the emergency clause to be able to be passed at the next Council meeting in order to get it back to ODOT by December 30th.

Mr. Bubb- I just wanted to point out that Mr. Cost noticed there is a typo in there, a 4 needs to be taken out.

Mr. Fraizer- as far as the remaining balance in the License Plate Permissive Tax, do we have money left over after this allocation?

Brian Morehead- the next project will pretty much use up the remainder balance for the rest of the year.

 Resolution No. 16-103 a Final Resolution cooperating with ODOT in the addition of turn lane at the SR 16 eastbound off ramp at the Church Street exit (ramp C, ramp 45054), lying within the City of Newark was discussed.- LATE ITEM **Brian Morehead-** this is a late that came about 15 minutes after Autumn sent out the agendas for the meeting so my understanding is that this can be read at the next meeting but not passed until the following meeting which would be fine because ODOT doesn't need the documents back until January 13th. It is a project that we have been working on for a year or so to widen that eastbound off ramp from State Route 16 at West Church Street and Country Club Drive intersection. We get a lot of back up especially when OSU Newark begins sessions and this will help move the traffic through that intersection a little easier.

Mr. Fraizer- is it the whole intersection that we are trying to improve not just the turn lane?

Brian Morehead- it is the ramp itself. The lanes on Church Street are appropriate. It is the off ramp that will be widened, you will have two lanes. **Motion passed by a vote of 5-0**.
