#### **COMMENTS FROM CITIZENS**

**Rochelle Volen-Smith, 237 Violet Ct.** – On Ordinance 22-14 I'd like to remind the City that if you're going to put restrictions on the streets there, I see several options, either you can close off those streets so they are pedestrian only, or you can educate the public as to how to work together between bicycles and other vehicles, so that it's safer. I realize that having food in the sidewalk areas does impede the sidewalks and the space, but I think before you institute this that we need to have some sort of education system.

#### **MISCELLANEOUS**

**Mark Mauter, Director of Community Development** – Thank you all for passing Resolution 22-32, that's going to allow me to make the deadline with the Sate of Ohio's Department of Development for the Brownfield Remediation Funds on April 30<sup>th</sup>, so that is very important, thank you again. The second reason I come before you tonight is because we are going to conduct the first of several Newark City Clean-up Days. This particular one will be happening this Saturday from 8am – noon. We are partnering with the Hudson Avenue Historical Society, as always it's a collaborative effort between the Department of Development which uses our CDGB Funds to pay for expenses, we partner with joe Paul and his Property Maintenance Office and we also use Jeff Hotchkiss' team to help us collect the items for disposal. We're going to be set up at 191 Hudson Ave. in the gravel lot north of the Church. As always we sent out 1300 letters to the residents this year telling and reminding them this is coming and telling them they can call in and make a preset appointment for large items and we'll get that taken care of for them. It's been a great program, we've partnered with Shackleford disposal and it's been very successful. The area that we're going to outline is Eddy St. to the west, Shields to the north, Clinton St. to the east and basically route 16 to the south.

**Mayor Jeff Hall** – Three quick things, first I'll echo the words of Treasurer Feightner, while serving in the a couple of years, it is wild and crazy. Now everyone is wiping their brow that they've submitted their taxes, now they've got to process all of those returns. So, it isn't like the work's all done. That's when the work really starts for them, but they will shut down for a couple weeks, process thousands of returns and then reopen to any citizens who might have missed that deadline. We appreciate all the hard work they do, they bring in great income tax. Yesterday morning started with kind of a tough time with a fire at Newark Station. While many people at 8am were getting ready for Easter breakfast we had firefighters and police already on the scene for nearly 4 hours. They did an outstanding job and we've met a few times since then, I was on scene for a bit, Councilman Barker was there, it was tough for the overall, but on the other side it was in a building where they had not done any work yet and the intentions were to probably remove the building ultimately, so there are parts that could've been worse I want to thank Joe Paul, Jim Smith and Bruce Gossett, Asst. Chief Doug Vermaaten and his entire team, the Police Department and the mutual assist, any type of fires like this we help them, they help us. We sign agreements for that and it's just outstanding. I will tell you that the \$1.4 million we spent on the bucket truck came into play yesterday. Very important. We had both ladder trucks up that have both been purchased since my administration, but with that one they were even able to go in and look at some things, not just put the fire out. They pumped probably literally millions of gallons of water on that fire. It is contained, there is a wall that remains challenging so we'll work on that. West Main Street will remain closed, there are alternate routes obviously, but at this time we have to keep it closed for pedestrian and vehicle traffic. Finally, the Newark Police Department was founded in 1870. Why do I say that, because today a monumental occurrence happened we promoted our first female into the position of Sgt. So, we have our first female Sgt. in over 150 year history of a department. April Fleming, Officer Fleming, what a phenomenal story, she told a little of her story, she started in the Heath Police Department and listened to the radio and said I could never handle that kind of call volume. Well, she came in as a dispatcher first and then said a few years later I think I'll go for to be a Patrol Officer and I think that's a cool story and now she's a Sgt. Kudos to April Fleming, she's a go getter, a hard worker, she's determined to accomplish her goals and we're real happy to have her on board. She was just a pinch nervous today, which I told her was important because it was an important day, but we got her to smile a little bit. She has a great team down there and will do a phenomenal job.

Law Director Tricia Moore – First I want to echo the Mayor's sentiments about the Police Department and Fire Department on their work on that fire downtown it really was a very large fire and they did an amazing job getting that under control. I also wanted to thank Engineer Morehead and Caroline Clippinger in my office who diligently worked hard on that easement this past week and were able to make that happen for that home buyer, so thank you. I also had the privilege of attend coalition for care Fashion for Compassion Show, Mrs. Hottinger was one of the models, she did a great job, our waiter was Senator Hottinger, so it was a fun event, I learned a lot about that organization and am looking forward to working with them on our Domestic Violence Task Force to help victims find emergency housing and things like that, so if you missed it look for it next year. I also want to thank Director Rhodes for his assistance on a project we are working on, we appreciate his help. I was also able to attend April Fleming's swearing in as well, a great day for the City of Newark. April is a phenomenal Officer as well as a wonderful person and she'll do a great job for the Newark Police Department.

**Ms. Hottinger** – Just three quick things. I want to thank Mr. Mauter for telling us about the neighborhood cleanups, twenty years ago when I was on this Council that was a big deal for neighborhoods to be able to get their neighbor hoods cleaned up, so I hope we continue to do that. I wanted to tank Mrs. Smith on your positive comments tonight in your first go-round, that's nice when we can give recognition when it's well deserved, so thank you for that. I also want to say kudos to Sgt. Fleming, I was not able to attend that today, but certainly it's a great day for Newark.

**Mr. Houser** – I just want to send a shout out to the Licking County Library, they put together a film on the 1942 Hudson Avenue bomber crash and obviously I'm one of the youngest Councilmen here and should probably know about that, but honestly I had never heard that

story before until Mr. Harris said I should definitely check that out. Well worth the watch. Fantastic job by the Library and I certainly learned a lot. The Horizon presentation was really good and I am excited to see what that will look like through committees. Also, a shout out to the Treasurer's Office, fantastic job as always I appreciate all their work. Thank you to the Law Director and her team for that easement legislation for a resident on my street, I appreciate that.

**Mr. Labutis** – Just a couple thank you's. A couple of weeks ago GCA had their auction and it was very successful. I don't have a final number, but I would like to thank my colleague that were able to attend that evening. I would also like to congratulate Dr. John Berry and his team at COTC who celebrated their 50<sup>th</sup> Anniversary providing education in the community and I would like to thank Director Rhodes for his help on a problem.

**Mr. Lang** – I just want to thank all of my colleague who've reached out on the passing of my mom, it's been a hard few weeks. Hers was the first campaign I worked on in the Village where we grew up in Chagrin Falls and I was about 8 years old knocking on doors with her was my first foray into politics, so it's kind of hard coming back here tonight, but just thanks to everybody who has reached out.

Mr. Marmie – I will call a Finance Committee Meeting for May 2<sup>nd</sup>. I want to really thank the Law Director's Office on that easement, by the time I reached out to our Law Director and asked her if she would get it done in time for us to have on last Thursday, I was astonished when she said it was already down there, so that's fantastic service, I really appreciate that. You and your team did a really great job of helping those folks out. Congratulations to April, I'm sure that she's got even bigger and better things ahead of her. I'm really happy for her and for the department. I'm really pleased with our Safety Services right now, the Fire Department has been busy, our Police have been busy, it's just been unbelievable. I don't know but we hear a lot of sirens out in my house and we have this neighborhood chat with all the guys and it's like what's going on, what's going on and Sunday morning I got a text at about 4:30am and it's just a sad situation, but fortunately it's not one of the buildings that is an immediate improvement that is going to be happening and it's not going to slow down progress on that. That is very good to hear about that. The last thing I'm going to mention is that on Mya 7<sup>th</sup> at TJ Evans there is going to be a trout derby and for kids 8am-10am and adults 10am-noon. We've had this in the past and it's going to happen again this year, so I welcome anybody to come out and join the trout derby.

**Mr. Rath** – I want to call a Service Committee Meeting for May 2<sup>nd</sup>. I just want to say I'm really happy to see 22-31 go through, that was the legislation that provided funding for body worn cameras for our Police Department, after several months after mentioning that initially, I'm glad to see we're getting around to that and that's going to come to fruition.

**Mr. Rine** – I'd just like to echo what Mr. Mauter said, this Saturday 8am – noon we'll be cleaning up. I'm a member of the HCA so I'll be there, the 7<sup>th</sup> ward definitely needs it, where we're going to be needs cleaning up, I've done a little bit, but there's just so many. SO, if we can get kind of like how they deer hunt, if we can get in a line and just go down the road, I think it will look a lot better Sunday morning.

**Mr. Barker** – I would just echo the comments of the Mayor earlier in regards to our Newark Fire Department and our mutual aid team. AS the Mayor said I was down there Sunday morning with the owner as well as the Mayor and the entire staff there. One of the comments made to

me was everything today went right. Now the fire wasn't right, but everything with mutual aid, with our fire department with our street department, everything went right for them. I think we should be very thankful for that. As the Mayor said there is still work to be done and everyone is working very diligently on that. Congratulations to Sgt. Fleming, I think that's fantastic, it definitely is a great thing for us here in Newark and should be seen as a great thing in central Ohio.

Ms. Bline – I too want to thank the Fire Department, I was there as well, checking on the residents and making sure they were not affected. I'll be honest with you I was trying to film this new piece of equipment that we just bought and finally I just put my phone down because it was amazing just to watch the agility of this bucket truck and I was thinking what would've happened had we not had that. It was just really amazing and so the citizens send their gratitude for that truck as well. I want to congratulate Officer Fleming and back to the Fire Department, so many residents were getting calls from people in other parts of the state complimenting the fire department on what a fantastic job they did. I just want to pivot here and thank John Hall of St Vincent De Paula and Jeff Vandyne of AEP. In November and December we started talking about the possibility of hanging lights down at the gardens on 6<sup>th</sup> Street. I don't know if anyone's ever been there but it's very or it was very dark at night. You really couldn't see your hand in front of your face in places, so gratefully we continued chatting and working things out and now, it looks like a baseball field down there, so I'm very grateful that St Vincent De Paul voted to hang those lights. I'd also like to congratulate Jeff Vandyne of AEP he has helped the City a lot in some projects. I'm looking forward to a community cleanup April 30<sup>th</sup> in south Newark, I'm excited about that. We've already started and so you all come, it's going to be fun.

**Mr. Harris** – I want to thank Mr. Loomis, I went to him about a month and a half ago about these people wanted sewer and their parents had an opportunity to get it years ago and when I went to him, he knew exactly where I was talking about. He told me tonight it was 2004, so Mr. Loomis has still got it. I want to thank BJ Varner, he helped mw with a couple street lights and I want to thank Brian Morehead for getting the paving started early this year, it's exciting. I want to than Jude for doing the pledge, that was the Law Director's son. May 14<sup>th</sup> is the east end clean up and then one more thing, on Thursday,, April 21<sup>st</sup> at 4pm, there will be a Charter Review Meeting in Council Chambers. Next meeting will be May 2<sup>nd</sup>.
