Mr. Labutis - I just want to take this opportunity to congratulate Par Excellence on their breakfast yesterday morning, it was a great program, they had a fantastic speaker, so kudos to them.

Mr. Marmie - I need to call a Finance Committee Meeting for February 5th. One thing I want to comment, I want to congratulate our Fire Chief and our Deputy Fire Chief, at the end of the fiscal year, half way through the year we were concerned about the overtime dollars being spent on our Fire Department. We had the first half of the year approximately \$695,000 spent. They turned things around they made changes, adjustments, they hired, they did what it took and they not only had a plan, but they executed it well. The second half of the year we're just a little above \$256,000 in overtime, so the turnaround is significant. Without great leadership and also the support of all the folks in our Fire Department, they did a great job in that second half and I appreciate it and not only that, noones life was in jeopardy, they just did more with less and did an effective job with it and I really appreciate everything they did in the second half. I appreciate them all the time, but man that is just something, what they did as far as that turnaround that I appreciate the leadership and Deputy Chief if you could pass that along to the Chief, I appreciate it. Then just one closing remark, I would be remiss if I didn't comment on a couple of losses that this community had. The first of which was just a gentleman who was just service above self, if you've ever known the term service above self, T.D. Griley was just

somebody who did phenomenal things for the Rotary organization, not just here locally, he did it district wide and throughout the United States and internationally. If you look at all the accolades that gentleman had and what he did for this community, what he did for Rotary and international Rotaries, know n for the fight and eradication of Polio and all the different things and we lost a really great gentleman and citizen of Newark here recently. Then secondly, we lost a great coach and definitely someone in the Newark Catholic community, Coach Cannizaro recently passed away on Saturday. He'll be missed, he's a record setter, he won 7 State Championships, inducted into not only the Newark Catholic Hall of Fame, but the Ohio Baseball Hall of Fame for High School. Just a great individual that served the community, did a lot for Don Edwards Park, was a coach with the World Series teams when they were here and not only that, he was a Postal Delivery guy in our community also that just did a lot and so he will be sorely missed also.

Ms. Bline - I'd like to thank Parks Director Patznick concerning the Town Commons name change to Hope Park. We met with her committee and they voted in favor of making that change and further repurposing that park. It's still kind of fallow and underused so we had a dream session on how we might like to further use that to get more people down there, so when that legislation comes, I would appreciate your support on that. I'd like to thank Mr. Balderson's office and Genesee and Wyoming Railroads for their help in securing the Federal Inspection records for Raccoon Creek Bridge. A few citizens and myself certainly had been questioning concerning the infrastructure, what's going on there and they were very kind to pursue those records. I've submitted copies of this inspection to our City Engineers and to our Council Clerk, if anyone would like to have a look.

Mr. Cost - I had a conversation today with Deb Dingus, she's the Director of The United Way of Licking County and she's also the Pastor at Trinity Lutheran Church on West Main Street. She and members of her congregation and a number of volunteers are running a warming center and it's making a huge difference. I think today she said they had twenty some people and four dogs at the warming center and they're feeding these people and the animals and housing them and because of the work they are doing those people have a warm place to sleep at night, I think that's to be incredibly admired and I'm hoping that we can lend some help in her direction.
