COMMENTS FROM CITIZENS

Doug Rothert, VP/Manager of Modern Welding Company – Thank you very much. We are located off of 79 by Grant and Union St. We have been in Newark since 1944. I've personally been with the company 35 years. I've been here in Newark 22 years. For many years we have struggled with some issues around our property. We had a large community of homeless that were starting fires. We've had numerous break-ins to our office and our shop. We've had to put security cameras up in order to catch these people. We've had personal vehicles broken into. We've had company vehicles broken into. I fought that for many years. It was kind of overwhelming what we had to deal with. I had kind of given up because even though we made numerous calls to police and fire, they came out to put these fires out, take care of it, it was just such an overwhelming situation. They always responded in kind, and took care of the situation at the time, but it kept growing. It was due to the overgrown woods between 79 and our property. There was too much room for them to hide. Several months ago, I had pretty much given up on this. I received a call and a visit from Miss Beth Bline. She came to my office and she had some concerns regarding the activity going on in that area. Her and I began speaking about that. I told her my concern, my issue with my property. Fences being cut, broken into. I will be honest, I'm not a public speaker, I'm not a political person. My first thought was, what is her agenda? I realized quickly she had no agenda. Her main concerns were the victims of the people, the kids, the female trafficking, the drug use going on in this property. After speaking with her a short period of time, I started receiving calls from ODOT who owned the cul de sac area, also the Ohio Historic Society which owned the woods. Within a couple of months, we stood outside in that field where the mounds are right now, with ODOT, Historic Connection, State Representative Claggett had been there before, and the Newark Fire Marshall Smith. We stood there for probably two hours talking about the situation, what the problem was, what needed to be done. We talked it out within a couple of hours. It was three days later ODOT and the Historic Society decided that the woods needed to go. ODOT came in and tore those woods down. Historic Society will now be taking that over. They're going to turn it into a green space. I then still had an issue with the property behind me which was owned by the railroad. Beth got me in contact with the correct person there. We now have permission to go back there and clean that area out to keep the homeless from being back there. Again, I know this is not the end all be all solution to this problem, but it was a tremendous help to us. It's made the area look a lot better, and I felt it was important to come in and recognize this woman. She did not have any agenda other than taking care of the people of this community. She wanted to take care of our company. We've been here since 1944. She wanted to make sure we were taken care of and the people of this community were taken care of. I just wanted to come and recognize and thank her for that. Thank you for your time.

Amy Shaw, 215 Elmwood Ave. – I would like to show you guys a few pictures. My husband's truck was stolen on October 31st, and this is what happened to it. (Ms. Shaw presented on her phone a picture of a wrecked truck.) This is what happened to my husband's truck after they stole it. It just messed everything up. The next picture I want to show you is a fire. They caught a truck on fire outside the front of my house. Not my husband's. I got a picture on there showing you what my street looks like. It

is totally dark. One street light on the whole street. There's another one, but it never works. That's just ridiculous. It's so dark that I do not feel safe outside my home in the dark. I've been begging for 30 years for more street lights. This guy said he was going to help us. He was one of the detectives. We have security cameras, but you can't see these people because it's so dark. I want street lights. That's all I'm asking for. Before the pandemic, we got this. The person that brought this paper to our house said that we were going to curbs. We don't have curbs. We get three feet of water in heavy rain. Said we were going to get drainage. We haven't got that. This is what my street looks like sanding in front of my house. (Ms. Shaw presented a picture on her phone of a dark street.) What can I do to get street lights? I've been begging for 30 years. We've lived in our home for 35. There're all kinds of stuff being stolen.

President Harris – See the gentleman back there, Dave, talking to the police officer? **Ms. Shaw** – Yes.

President Harris - Talk to him about street lights. He can help you. Ok?

Ms. Shaw – It's going to get worse and worse. The police officers that came for the fire said they were going to try to do something, but we haven't heard anything.

President Harris – Get with him after the meeting and see if he can get some help, ok? **Ms. Shaw** – Ok.

Sandra Hooker, Grove City – I am a State of Ohio Ambassador for change against distracted driving. I am advocating to change the culture of our state beginning at the local level, and to promote a more preventative measure to reduce distracted driving. I also want to advocate for harsher penalties and more rigid enforcement against distracted driving to make the motorist more responsible for the action behind the wheel while driving. I am here to raise awareness to our citizens and our pedestrians of the danger of distracted driving. Everyone has to understand, taking your eyes off the road, for whatever reason, can cause you to drive distracted. There is no justice for the injured person, and it's wrong. The driver should pay a hard penalty for their action. Distracted driving is dangerous and can cause catastrophic injuries. These types of injuries can be long-lasting, and you may never heal from them. Drivers need to slow down and be accountable for their actions when driving. Those who drive distracted and cause bodily injuries to others should be prosecuted to the fullest degree of the law. The law needs to change to benefit the injured person, not the motorist. I propose to City Council to raise your penalties at a local level from \$150 to \$750, a second-degree misdemeanor, and a firstdegree misdemeanor to \$1,000 if the injury results in a death or permanent paralyzation. Taking care of a paralyzed person hard, forever, time consuming, and exhausting. We don't need an apology from the distracted driver. We need accountability. This is a serious issue. Crosswalk crashes are at an alarming high, and people need to slow down and pay attention when they are driving behind the wheel. This dangerous issue needs all tools available to prevent and reduce this bad behavior and habits of distracted driving. I really want to make it a criminal crime. The current penalty is nothing but a slap on the wrist for drivers who cause bodily injuries to a human being. The motorist is charged only \$150, and no justice to their actions. This is not acceptable for the good of our citizens and pedestrians. Please help and support my effort to change the local level of penalties and laws in distracted driving and crosswalk crashes. This is not enough of accountability for their distractive driving. I'm here because my son got hit in the crosswalk, and he was handicapped. Nothing like this came in my family, and it hurt my heart. It turned me to be an advocate against distracted driving. I'm traveling from city to city talking to the City Council trying to raise the fees. You don't even have to raise it to 750 like Grove City did. I just feel that unless you do something about changing the penalties and make them pay for what they do, I'm going through so many changes because my son lost his ability to pay his bills because all his money got to go towards his rehab center. He don't get but \$950, and then the creditors are coming and begging for their money. I keep saying my son is sick. He's on disability. I don't think \$150 is enough. So, I'm out to campaign to change all of that, and I think every city should take notice about what the families have to go through when their family gets hurt or killed. The injuries can be catastrophic. The victims should get justice. Thank you.
