### We wish to report :

1. **Resolution No. 22-47** A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF NEWARK TO PREPARE AND SUBMIT APPLICATIONS TO THE OHIO GOVERNOR’S OFFICE OF CRIMINAL JUSTICE SERVICES FOR FISCAL YEAR 2022 EDWARD BYRNE JUSTICE ASSISTANCE GRANT FUNDING.

It’s for fines for the NPD when they’re involved in arrests, whether it be in the City, the County or even outside of the County. Fines that are collected whether it be Municipal Court, Common Pleas Court. When these fines come back we need to make a separate fund within our office for these to come back and the NPD can be the recipient of these. You see what these funds can be used for, there can be a multitude of different uses. It’s hard to tell what kind of number this will be, but it could be advantageous for our Police Department to use to fund expenses and it is

also required by the Auditor of the State. The reason for the emergency clause is to be in compliance with the State.
