We wish to report:

Mr. Marmie - The unappropriated balance of the General Fund is \$575,970.00 and the balance of the Budget Stabilization Fund is \$578,513.00.

1. Resolution No. 24-81 A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF NEWARK TO PREPARE AND SUBMIT APPLICATIONS TO THE UNITED STATES BUREAU OF JUSTICE ASSISTANCE FOR FISCAL YEAR 2024 EDWARD BYRNE JUSTICE ASSISTANCE GRANT FUNDING.

Barbara Gilkes – This grant we share with the Licking County Sheriff's Office. Newark police will be putting their share of the funding towards a cab monitor. The Sheriff's Office will put their share towards the purchase of AEVs.
