### We wish to report:

1. Resolution No. **23-74** A RESOLUTION AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE TO ACCEPT BIDS AND SELL CERTAIN SURPLUS PERSONAL PROPERTY NOW OWNED BY THE CITY OF NEWARK, OHIO, AND DECLARING THAT SUCH PROPERTY IS NO LONGER NEEDED FOR ANY MUNICIPAL PURPOSE, AND DECLARING AN EMERGENCY  
**David Rhodes, Service Director** - As always, we would like to have a municipal auction where we get rid of these surplus items from the impound lot and anything else we have around the City. This years auction will be held on October 7<sup>th</sup>, the reason for the emergency clause is for advertising purposes to meet deadlines.

2. Resolution No. **23-76** A RESOLUTION AUTHORIZING THE CONVEYANCE OF CERTAIN REAL PROPERTY NOW OWNED BY THE CITY OF NEWARK, OHIO TO NEWARK DEVELOPMENT PARTNERS AS ITS AGENT FOR INDUSTRIAL, COMMERCIAL, DISTRIBUTION, AND RESEARCH  
**Director Rhodes** - The City owns a piece of property at 18 West Sinclair Street, it adjoins another piece of property that NDP has, we can combine the lots.

3. Resolution No. **23-77** A RESOLUTION AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE OF THE CITY OF NEWARK, OHIO TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACT FOR THE OFF-SITE DISOPOSAL AND BENEFICIAL REUSE OF LIME SLUDGE FROM NEWARK’S WATER TREATMENT PLANT.  
**Director Rhodes** - Lime sludge is created when we put lime in the water to soften it, after the lime has done its job it goes through some pipes down into a pit, we have to pay to haul it away, this is a three year contract starting the beginning of January.  
**Motion to send to full Council by Mr. Barker, second by Ms. Bline, motion passed 5-0**
