

# Project Title: Water Plant Lime Sludge Reuse/Disposal Contract

A RESOLUTION AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE OF THE CITY OF NEWARK, OHIO TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACT FOR THE OFF-SITE DISOPOSAL AND BENEFICIAL REUSE OF LIME SLUDGE FROM NEWARK'S WATER TREATMENT PLANT.

## Background/Purpose:

The Water Treatment Plant generates approximately 25,000 cubic yards of lime sludge per year and must remove and beneficially reuse the dried material from three lime lagoons.

#### Scope of Work:

The Division of Water and Wastewater, through the Director of Public Service, is requesting authorization to enter into an agreement for this project. This work will include removal, hauling and land application as agricultural product.

## Justification/Urgency:

The current 5-year contract expires January 4, 2024. It is in the best interest of the City to bid the new contract by October 2023 to allow adequate time if a new contractor is selected.

# **Anticipated Costs and funding source:**

The estimated annual cost is \$200,000. The contract is funded through Operating funds under the Water Department.

# Schedule or Term of Contract:

The current contract expires January 4, 2024 and it is expected the new contract will be 5 years.

#### **Governance:**

Current legislation is needed to bid the contract and enter into an agreement.
