A RESOLUTION AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE FOR THE CITY OF NEWARK, OHIO, TO ENTER INTO A PURCHASE AGREEMENT WITH RINKER MATERIALS FOR THE PURCHASE OF A CONCRETE PIPE TO REPLACE THE CURRENT STORM PIPE ON RIVER ROAD WITHOUT COMPETITIVE BIDDING AND DECLARING AN EMERGENCY

WHEREAS, the current storm pipe located on River Road at Park Trails Subdivision is failing and immediate replacement is required for the preservation of the public peace, health, safety, and welfare; and,

WHEREAS, this Council, by passage of Resolution 24-97, authorized participation in the Ohio Department of Transportation's cooperative purchasing contracts through OhioBuys for the purchase of machinery, materials, supplies, or other articles and services, thereby allowing the City of Newark to acquire essential supplies, materials, equipment, and services without competitive bidding and at a lower cost; and,

WHEREAS, under such program bidding is waived as the Ohio Department of Transportation has entered into contract for the benefit of the state and local municipalities under ORC 5513.01(B); and,

WHEREAS, Rinker Materials is a qualified supplier through the OhioBuys cooperative purchasing program; and,

WHEREAS, in order to preserve the purchase price of the pipe by the authority granted herein, this legislation is to be expedited as an emergency pursuant to Article 4.06 of the Charter of the City of Newark.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEWARK, COUNTY OF LICKING AND STATE OF OHIO, THAT:

SECTION ONE: The Director of Public Service is hereby authorized and directed to enter into a purchase agreement for the purchase of one (1) concrete pipe utilizing pricing established by the OhioBuys purchasing program as allowed under Resolution Number 24-97, with Rinker Materials, a qualified supplier under the OhioBuys program, thereby waiving any competitive bidding requirement.

SECTION TWO: This Resolution shall become effective immediately as an emergency pursuant to Article 4.07 of the Charter of the City of Newark, Ohio for the immediate preservation of the public peace, health, safety, and welfare.
