# 25ET 2025 Estimated Tax Instructions

If the Newark tax you owe after all credits is \$200 or more, you are required to file an Estimated Tax Return and pay your taxes quarterly.

#### Part 1 - Account Information

Account	Enter your Newark Tax Account Number. If unknown, leave blank.	
SSN	New State Law requires you to enter your full Social Security Number. If you are filing jointly, please enter your spouse's full Social Security Number.	
Resident Address	Enter your street address including city, state and zip code. If your mailing address is different, please write it on the back of this form.	
Phone	Please enter a number where we can reach you if we have any questions.	
Email	Please enter your Email address.	
Filing Status	Please place an X in the box beside your filing status.

- **Line 3** Enter the amount from line 3 on your 2024 Return.
- *Line 4* Enter the calculated credit from line 4 on your 2024 Return.
- **Box 6** Enter the total of Lines 3 and 4.
- **Box 7** Subtract the credits in Box 6 from the tax in Box 2 and enter the difference.
- **Box 8** Multiply Box 7 by 0.225 and enter the result.
- **Line 9** Enter the amount from line 8 on your 2024 Return.
- **Box 10** Subtract Line 9 from Box 8 and enter the difference. This is the payment due with your Estimated Tax Return.

#### If Box 7 is \$200 or more, you must file this form even if no payment is due in Box 10.

#### All other taxpayers follow these instructions:

- **Line 1** Enter the amount of income you estimate you will earn in 2025 that will be subject to Newark Tax.
- **Box 2** Multiply Line 1 times 0.0175 and enter the result.
- **Line 3** Enter the amount of Newark Tax your employer will withhold from your wages.
- **Line 4** Multiply the income that you will earn in other cities times 0.01 and enter the result.
- **Line 5** If tax will be paid on your behalf by a partnership or other entity, enter the amount that will be paid.
- **Box 6** Enter the total of Lines 3, 4, and 5.
- **Box 7** Subtract the credits in Box 6 from the tax in Box 2 and enter the difference.
- **Box 8** Multiply Box 7 by 0.225 and enter the result.
- **Line 9** Enter any credits that have been carried forward from a previous year on your Newark Tax Account.
- **Box 10** Subtract Line 9 from Box 8 and enter the difference. This is the payment due with your Estimated Tax Return.

#### If Box 7 is \$200 or more, you must file this form even if no payment is due in Box 10.

#### Complete your return by following these steps.

- 1. Sign and date your Estimated Tax Return. If filing joint, your spouse should also sign.
- 2. Mail your return with payment to the address listed below.
